### Recent Events



On August 23, Chairwoman Daniels and Supervisor Lucas attended an event in Ossining where NY State Senator Peter Harckham announced that North Salem and other towns in his District will each receive \$100,000 in funding for electrification projects under the Community Resilience, Economic Sustainability and Technology Grant ("CREST"). #### Westchester County Passes "Upon Request" Law Aimed at Reducing Foodware Waste

Beginning September 2, 2023, no food service establishment within Westchester County may provide single-use foodware or condiment packets to dine-in or take-away customers *unless requested*. This pertains to items such as forks, knives, spoons, chopsticks, cup sleeves, beverage lids and condiment packets.

This law upholds existing safety protocols for utensil storage within food service establishments and maintains standards of cleanliness upheld by the Department of Health. Food service establishments are required to display a sign provided by the County informing customers that plastic utensils, condiments, and straws are available only upon request. This law aims to address the billions of single-use plastic items that are thrown away in Westchester each year.



# Trip to Materials Recovery Facility

Committee Members took a repeat visit to the Win Waste Materials Recovery Facility in Stamford, Connecticut, and learned a lot about recycling...

The Committee had three critical takeaways:

- NO plastic bags can go into recycling not with paper - not with bottles and cans - plastic bags must be removed from the recycling stream by hand which is costly and slows down the process.
- Glass/plastic bottles and paper cartons should be clean and put into recycling without lids.
- 3 Don't put metal objects or concrete into the recycling it damages costly sorting machines.

## POLLINATOR PATHWAYS PROGRAM
