1. TO ISSUE A NOTICE OF NEGATIVE DECLARATION AND ADOPT LOCAL LAW 03-21

Motion made by Seconded by

WHEREAS, the Town of North Salem Town Board is considering the adoption of Local Law No. 3 of 2021 amending the Code of the Town of Salem, pursuant to New York State Constitution Article IX and New York Municipal Home Rule Law §10, to add Chapter 158 to opt-out of allowing cannabis retail dispensaries and on-site consumption sites from being established and operated within the Town of North Salem, as is authorized under NYS Cannabis Law Article 4 (hereinafter referred to as the "proposed action"); and

WHEREAS, the proposed (legislative) action is proposed pursuant to NYS Cannabis Law § 131 which expressly authorizes the Town Board to adopt a Local Law requesting the Cannabis Control Board to prohibit the establishment of cannabis retail dispensary licenses and/or on-site consumption licenses within the jurisdiction of the Town of North Salem, which Local Law is subject to a permissive referendum, the procedure of which is governed by Municipal Home Rule Law § 24; and

WHEREAS, the proposed action is an Unlisted (legislative) action pursuant to SEQR 6 NYCRR Part 617, for which a Short Environmental Assessment Form (SEAF) has been prepared assessing related potential environmental impacts; and

WHEREAS, the Town Board held a duly noticed public hearing, which public hearing was opened and closed on June 22, 2021, at which time interested parties were afforded an opportunity to be heard;

RESOLVED, the Town Board as the sole involved agency hereby confirms its status as lead agency for the environmental review of the Unlisted action pursuant to the provisions of SEQR 6 NYCRR Part 617. As lead agency, the Town Board has considered the Short EAF with corresponding Short EAF Narrative, as well as the comments and recommendations of its consultants and the public; and

FURTHER RESOLVED, the Town Board, as lead agency, hereby determines that the proposed Unlisted action will not have a significant adverse effect on the environment, and further determines that preparation of an environmental impact statement will not be required. As such, the Town Board hereby issues the attached Notice of Negative Declaration, which includes supporting reasons for its determination of SEQR Non-Significance; and

FURTHER RESOLVED, the Town Board hereby adopts Local Law No. 3 of 2021, which shall take effect immediately upon filing with the New York Secretary of State, pursuant to New York Municipal Home Rule Law §27.
